| T1 area of woodland situated between public footpath and adjacent farm buildings, woodland consists of a mixture of semi mature sycamore and beck side: hawthorn, hazel and alder. many of the smaller specimens have poor form and are leaning to the extent that they contact the farm buildings causing damage to the roof and gutters, proposed work is to prune back overhanging growth to provide 2 meters clearance from the buildings, this will allow for roof replacement to comence. The best access to view the area is from howley mill lane. |
