2 trees in the garden of number 40 parkside road, LS6 4QG.

The tree trunks are covered in lvy.

We would like to reduce the crown to 8 meters for balance and carry out lateral reduction over the road side to provide sufficient clearance to 2 properties.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - $\circ~$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
