I wish to install a hanging sign, indicating the shop name and logo, which will hang perpendicularly from the first floor similar to those on either side of the property (Costa Coffee and Tan Bueno). The sign would be approximately 1-1.25m high by 0.75m-1m wide, and hang off a metal bracket. I can provide an indication of what the sign would look like on request if you get in touch via email.

It is clear from screwholes in the the brick work on the first floor that the shop has previously had a similar hanging sign. This is part of an overall improvement in the shop premises, with new colours, new branding and new interior, and I hope it will enhance the premises.
