T001 - Oak, Crown raise to 4m and remove deadwood. Low branches over play equipment and deadwood located in the crown.

T003 - Rowan, Fell. Tree in poor physiological condition and deadwood starting to accumulate.

T005 - False Acacia, Fell. Large amount of deadwood is present in the upper canopy. Poor main union point at 1m where the tree bifurcates with decay present. Tree overhangs drive to hospital and farm.

 $\mathsf{TD8}$  -  $\mathsf{Oak}, \mathsf{Crown}$  lift to 2m. Tree is over paving, disabled parking bay and benches.

TD9 - Sycamore, Remove deadwood. Minor deadwood over exercise equipment.
