On the evening of 24th January 2024, during storm Jocelyn, a large horse chestnut tree (trunk diameter of at least one metre wide) within the grounds of Irwell Vale Methodist Church fell narrowly missing a neighbours' house but causing significant damage to her boundary wall, outbuilding and adjoining garage. On this occasion we were very lucky that the tree fell in the direction it did. Any other direction would have caused significant damage to buildings and potentially resulted in serious injury or loss of life. The neighbour in question and others living in the vicinity of Irwell Vale Methodist Church expressed concern of the height of some of the other trees within our grounds and made a request to the church for them to be cut back to a more manageable and safer height. We instructed a local professional arboriculturist company, who we had used to remove the fallen tree, to carry out an inspection of the remaining trees within our grounds and provide a quote as to what work they advise we need to do. During this survey they discovered two ash trees with ash die back, a horse chestnut very close to an adjoining neighbours property that the neighbour in question is very concerned about and has asked for it's removal and two very large lime trees that need reducing to a safe and manageable height. I have attached the quote for the works advised by this company (Quote QU-0056 from DLC TREE SERVICES).

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
