To Monolith (T1) Ash Tree to approximately 8ft.

This is due to finding Kretzschmaria and Horse shoe fungus at the base. As the Tree is in close proximity to the owners property, this will significantly reduce the risk of significant damage.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
