Remove major and obvious deadwood of Robinia tree in the west rear garden of 23 Hardy Road. Crown reduce small Yew Tree by 0.5m on the west rear garden of 23 Hardy road, trim side and to remove current season growth to retain natural shape as much as possible. Crown Reduce big Yew tree by 2.0m at the east rear garden of 23 Hardy Road, trim side growth to retain natural shape as much as possible.as well as to allow more light into the garden.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
