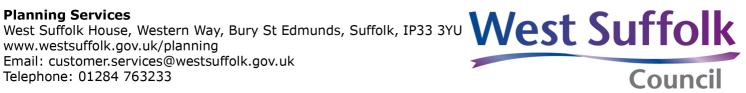

Advice received: Mr Cannon consulted with Listed building team, they could not see any issue with the conversion as the garage was built in
1980 and outside of the main curtilage of the main building.
If the garage is free standing and post dates 1 July 1948 it will not be curtilage listed and would not require listed building consent to alter it.
