T1 - T4 - Cedrus libani, reduce all crowns by 1.5 to 2m holistically to lessen sail profile and potential for snow loading due to catastrophic branch failure in the past. Also to reduce from proximity to building profile. Routine maintenance last carried out in 2019.

T5 - Lime tree, poor main union, deadwood dropping frequently, reduce crown by 2 to 2.5m from all aspects, crown dimensions to change from 16m x 7m, to 14m x 4.5m considering the pruning to suitable points of strong growth.

G1 - Reduce all Holly trees to 1m in height, as has been undertaken in the front of the school to re-instate screening hedge. This has been highly successful in the front and is required at the rear.

T6 - Oak tree, and small, suppressed, misshapen Sweet Chestnut below, please refer to attached arb report, reduce limb overhang to specific points by 8m and coppice Sweet Chestnut, for the safety of the occupants backing on. [Referred to as T719 and T720 in attached report]
