Behind the garage at the bottom of the drive is a deodar cedar growing very close to a power line. The power line company has told the customer the tree needs removing and the customer would like the tree to be fully removed.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
