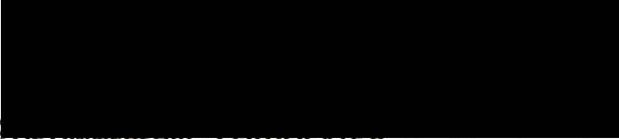

Good Morning David,

I carried out a visit to the above site (Pro Nano) on Wednesday and your client the operator has asked me to contact you directly.

The screens that are required to be fitted are still not in place. However I did note that cars were being washed towards the rear of the site so that the correct drainage is being used, there are retractable plastic curtains being used to separate the washing area from the valeting area. There are on a wire and can be pulled back at the end of the days operation.

Your client currently has two in place but stated that he wants four of them.

If your client wants to operate the car wash with these retractable screens then an application for a variation of conditions is required to obtain approval for the current set up.

To avoid the Council having to take formal action this application will need to be submitted by Monday 20th November 2023. Can you confirm that you will be submitting the application on his behalf by this date.

On my visit I did note that the tyre bay is now operational and we have communicated previous regarding the breach of condition in relation to the hours of operation of the car wash. You did mention that you considered that the car wash could operate to 6.30pm Monday to Sunday once the tyre bay became operational.

I am satisfied that this is not the case, the hours condition (condition 8) of planning permission DC/087492 relates to the tyre part of the business only, this is following a comprehensive noise report and due to the fact that any operation in connection with tyres can take place in the building only.

The Car wash can therefore only operate during the following hours.

Monday to Friday 8am to 6.30pm
Saturday 8.30am to 5.30pm
Sundays and Bank/Public Holidays 9am to 4pm

The hours are different as the car washing takes place in the open air and operation before or beyond these times will be detrimental to the amenity of the occupiers of nearby dwellinghouses. Can you impress on your client the requirement to comply with these conditions and to ensure that any signage reflects the correct opening hours to prevent the need for the Council to take formal action.
