Should an application be forthcoming, the single storey rear element should project from each rear building line by no more than 4m. In addition, the overall depth of the first floor rear extension needs to be significantly reduced. The ridge height should not be extended above the current height. Given this reduction to the roof volume, the rear dormers will also need to be reduced. The rear patio should be omitted from the scheme.
