Planning permission required.

Report conclusion:

Having studied the plans from previous planning applications however it is considered unlikely that any objections would be raised to the works proposed. The doors and balcony would be to the rear elevation facing the open fields to the rear and would thus not be readily visible from public vantage points.

Provided they of a similar appearance (the same materials and the same style and proportions) as the existing fenestration there would be unlikely to be any harm to the general character or appearance of the area.

It is also unlikely that the door would give rise to any greater overlooking of adjacent sites than the existing standard window such that there would be no significant harm to residential amenity.

The proposal appears to comply with Policies CS11 and CS12 of the Dacorum Core Strategy 2013.
