In my original proposal, I had indicated that I would render the new extension in the same way as the old. I would like to use a mix of pebble-dash around the windows to stay in keeping with the other houses in my row and an off-white render on the side facing of the extension and as detailing up the vertical outcrops to match the window frames.

If I were to use the same pebble-dash exterior as the original, it would actually make the house no longer fit in with the surrounding houses. Of the 12 houses immediately visible from around number 69, only 2 of them have full pebble-dash side walls and all of the houses on the extension side of the house use a white or cream render finish so using pebble-dash would actually stand out.

I think the result will be more in keeping with the houses on that side and will increase the insulation for the whole house. I attached some pictures of the original finish and some screenshots from Google maps to show the houses surrounding that side of my property
