Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The tree is a sycamore tree (T1). It hangs over the property boundary (onto a neighbour's garden and a private road) at the back of the garden and the leaves cause a lot of issues when wet. During the recent stormy weather the branches looked extremely precarious as if they might break off and fall onto a car in that word. The branches are also very close to the phone line that runs through the gardens and there is concern about abrading. There is also the concern about the roots going under the various houses on the private road near the tree. I would like the branches cut back to the trunk to reduce the height by several metres (to a max of 6m) to make it more manageable, thus reducing the concern about leaves, branches and roots. With spring coming, it will be easier to have the work done before the tree blossoms.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
