- 1. Reduce height of the row of leylandii running down the farm side of the property from approx 40ft to 7 8 ft high.
- 2. Remove 3 Fir trees of varying sizes to ground level, which are growing in close proximity to Large pine tree.
- 3. Remove 3-4 small groups of Hazel to ground level, which are congesting thee area one of which is close to rubbing against neighbours boundary fence.
- 4. Remove Leaning cherry tree.
- 5. lightly Prune Various fruit trees (apricot apple mainly) to re encourage growth of fruit again (understanding we will be just out of fruit pruning season and will look to complete these works nearer next winter) completely removing a selected 2-3 Apple trees to prevent further interfering and fighting for light between all fruit trees present.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
