Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
There are two remaining silver birches in our front garden - there were three until 2023, when the central silver birch fell down, landing against our listed house. The three that fell down last summer was pappy and pulpy through the wide centre of its drunk and had ovbviously been dying from the inside for some time.
We have been advised by a tree specialist to take down the two remaking silver birches in our front garden, as they are likely to be diseased
in the same way as the one that fell down last summer. We are particularly concerned over the older of the two trees, the one near our front gate and the shared path and pavement, as if it fell down, it could well damage the house and/or the wall or even passers by or the road. However, we have been advised that the silver birchin the other corner of the front garden may well also be diseased.
We have already planted three silver birches in the adjacent side garden and are willing to replant in the front garden.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
