The oak tree (Quercus robur) had permission to be crown reduced by 30% in 2018 (application number 18/05586/VP) the real reduction was closer to 20% at the time and was greatly appreciated, allowing more sunlight through and reducing the overall imposing height over the property. The applicants want to reduce the 1m regrowth back to the 2018 knuckles via a repollard. There is no intention to remove or harm the trees as they are enjoyed by the residents.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
