Tree - Birch tree

The tree is touching the neighbors building, pushing against the wall and guttering. Its is also heavily weighted over another neighbors garage.

I am proposing that we cut back 1.5 meters from the building, only removing smaller branches, nothing significant at all.

Over the garages I have proposed to cut the 1 heavy limb back by 2 meters reducing weight over the garage.

I intend to cut all branches in line with BS 3998 (2010) standards,

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
