T1 - Lime

Recommended dismantle and remove to ground level of T1 given extensive fungal brackets around base of trunk. Fungal brackets in 3 locations around stem suggesting the holding wood will be compromised already T1 has large union approximately 12ft from ground level which could become compromised with increasing decay in lower stem also.

Given T1's location, health and species, removal would be recommended
