Tree 01: Silver Birch
Remove tree. Replace with one flowering cherry of 10-12 cm girth
Reason: to manage unacceptable risk to road users
Tree 02: Silver Birch
Remove tree. Replace with one flowering cherry of 10-12 cm girth
Reason: to provide sustainable long-term tree cover and ensure future risk to road users is minimised.
Tree 03: Oak
Reduce in height from 19 m to no less than 17.5 m. Reduce in spread from 9 m to no less than 7.5 m. Remove three lowest branches back to stem as indicated on appended photograph.
Reason: to manage dominance over garden space
