Front Garden:
T1:Birch: T2: Lime: Remove drive block paving covering. Excavate around the roots which is lifting the drive. Remove surfacing roots to facilitate re-laying drive surface. There are tree roots lifting the surface which have become a trip hazard. The landscaper has confirmed that the tree roots are lifting the surface.

The roots are coming through from the T1:Birch in Front garden No.8. The T2: Lime tree is in the front garden of No.9. Potential hazard.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
