Following sign off, your decision will be sent to you. If your application is called to Planning Committee, your application will follow a slightly different path, details of which can be found on our website.

In all circumstances where this is the case, the Council will make a decision <u>as soon as possible</u> after the eight or thirteen week period. To avoid unnecessary exchanges of correspondence, the Council will assume you agree to an extension of the prescribed period for determination unless notified otherwise in writing.
