T1 - Crab Apple tree approximately 8 meters in height, situated in the front garden. The base shows poor root development whilst the crown has a surpassed form due to a larger nearby Ginkgo.

The description of the works is: remove the Crab Apple tree and a replacement tree is to be planted in a convenient location of the front garden. The Dulwich Estate has recommended three alternative species for consideration.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
