T1. SYCAMORE TREE (Acer pseudoplatanus): This large tree is growing well but is now overhanging the neighbouring properties and is a potential hazard in high winds.

It is recommended to reduce the height by 3-4m and reduce the span by 2-3m. This will leave an approximate height of 18m and approximate span of 15m Very careful tree surgery is required with various garden features, the fence and public path. There is also a historic listed wall and an electricity substation nearby.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
