The tree is a scots pine. It has uprooted and is leaning over our neighbours fence. It is going to fall down soon and needs removing ASAP! i have been in touch with a local tree service (J.P.COOPER) who is happy to complete the work and agreed it needs removing sooner rather than later as this will can cause damage for the neighbours but informed me that the tree is on a conservation area therefore i need permission from yourselves.
I am happy to send over pictures of the tree.
