Details of the pre-application advice received

The proposed design of the dwellings is considered incongruous within the streetscene, in terms of roof shapes and eaves height (which does not correspond with neighbouring properties). The proposed designs are considered convoluted and poorly designed. The proposed widths of the dwellings are also not considered in keeping with the "cottage" feel of other properties within the streetscene, which the proposals may be trying to recreate.
