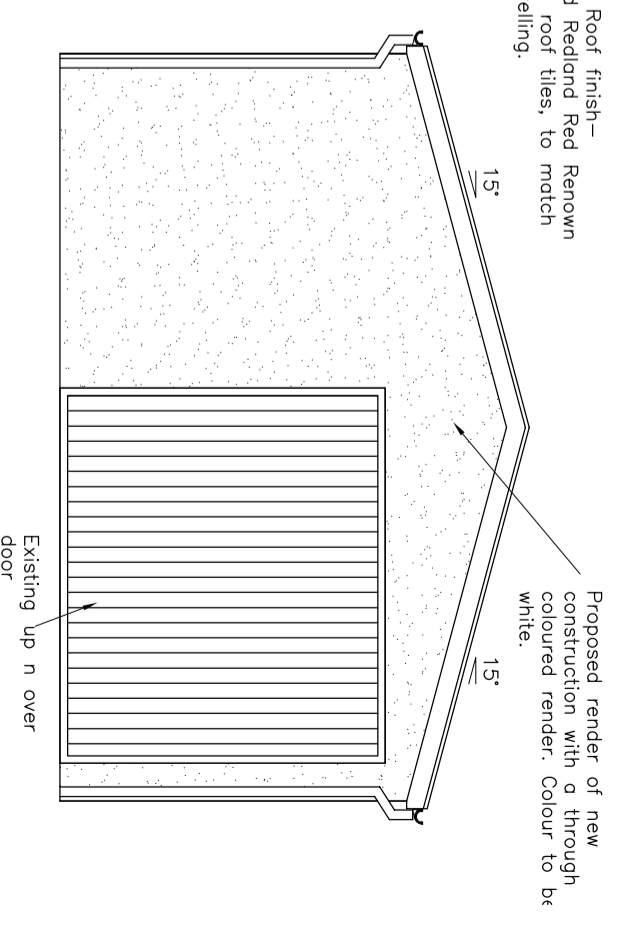
FLOOR PLAN
