Property purchased with workshop attached to the side of the property at the rear. Initially thought this would count as a conversion but required demolishing, adding concrete footings and recreating room to comply to building regs. Use of the room will be utility room. Original development was demolished and now applying concrete footings in line with property.

Then building up the room to secure brick, damp proofing, and insulating.

Works commenced on 27th feb based on certificate of lawfulness attained in January which was on the grounds of the build being a conversion.

Property has had workshop for several decades before our purchase. Our development will be creating a more secure and safe structure but still remaining within the boundaries of the property and not exceeding the original plot that the workshop was on.

As soon as we completed in the purchase of 30 Churchill road, I looked into whether the workshop was lawful in which I discovered it was not built correctly. I immediately brought this to your attention with our initial application.

Our development works started based on an approved certification of lawfulness which was based on a conversion. I initially believed it to be a conversion but since it has been demolished and will be recreated, we were informed a new application would be needed.

I wish to attain a certificate of lawfulness should we ever wish to sell the property in future.

Our main purpose for this application is to comply with the law and create a safer home without extending above original measurements of what was initially in place at the property.
