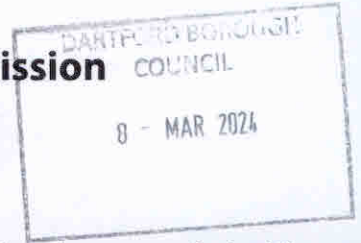

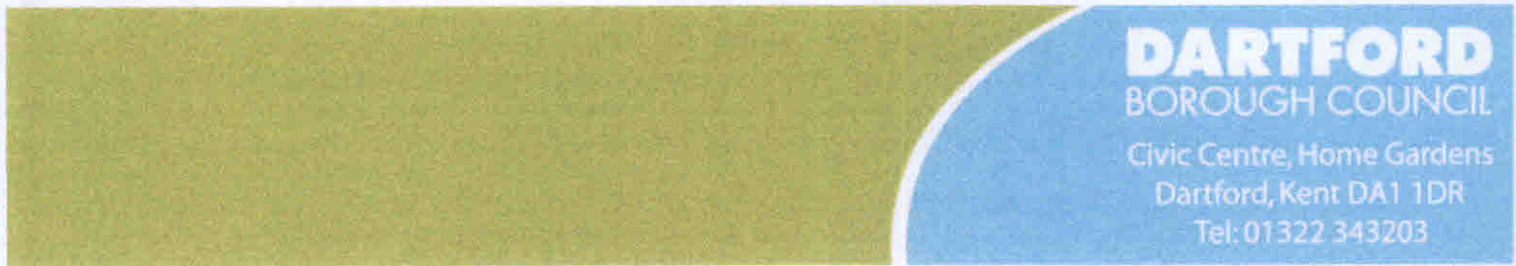

## 11. Biodiversity Net Gain
