We would like to remove a Hawthorn tree in our back garden. During the recent strong winds, large branches have snapped off which are a danger to our dogs and toddler who use the garden. Branches consistently drop into ours and the neighbours garden. A number of the branches are intertwined and there are no lower branches for the tree to re-establish the the advise from an arborist was to cut the tree down rather than prune it. Tree is marked with a blue cross on the attached plan. You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
