Tree 1: Sycamore - Fell

The tree has significant decay in the base and early signs of crown die-back - Remove for safety

A 1.5m-1.75m Liquidambar would be planted as a replacement tree in the Southeast corner of the property (Church Lane boundary).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
