Details of the pre-application advice received

Preliminary Proposals for the new building were shared with Tim Allen (Historic England Inspector) on site in December 2023. Mr Allen was positive about the design of the building and noted that it would be a considerable improvement for the setting. A separate SMC application is being submitted to Historic England concurrent with this application. Additionally the proposal has also been discussed in principle with Tony Sargent of North Kesteven DC's planning department, who noted that the council's planning policies wish to encourage renewable energy. Although Mr Sargent had not reviewed drawings, he was hopeful that the proposals might be supported given the positive pre-application feedback from Historic England.
