Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Outsized Weeping Willow Tree in the garden of 32 Saxon Street.
appx 17ft from neighboring property, 18ft from Saxon Street, 7ft Girth with a pronounced lean to the North.
The tree has been previously pollarded (over 6 years ago), and we had previously had an on site inspection by the Council's tree planning person who said there would be no objection if we wanted to remove the tree.
We have had issues with larger branches falling during strong winds onto the area that our children play in and have safety concerns from this along with concerns of possible damage to the neighboring property.
We wish to pollard the tree back to its original trunk in order to allow new healthy growth to develop and make future management more manageable.
We have had a quote for works from Arborist - Arborez Ltd in order to complete this for us pending your permission.
I enclose a rough diagram indicating location (Ref:AS1) and photograph of the tree (Ref:AS2)

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
