T1_T2_T3_T4; To sectional fell and remove T1,T2,T3 & T4. An existing Leylandii hedge which has not been managed and left to grow into mature trees. T2 has recently had a stem fail which brought down power lines and blocked Farm Road. The remaining stem has been significantly compromised with its main weight toward the homeowners property. If T2 is removed T1 would be left exposed to further wind damage. The proposal is to remove all four trees from the existing hedge and replant the hedge line with an appropriate species.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
