T1 Ash; To sectional fell to ground level. T1 is showing early stages of Ash Die-back with die back in the crown. T1 has not been able to mature as has been overshadowed and out-competed by the adjacent larger trees, it also has been compromised at the base with a cavity developing.

T2 Ash; T2 to sectional fell to ground level. T2 is showing onset stage of Ash Die-back, with die-back in the crown and stress related growth. The home owner wants this tree to be made safe to avoid future issues.
