T1 - Eucalyptus - Remove low limb over hanging access road back to main stem. Reduce remaining crown to 1m below previous reduction points.

To provide clearance over highway. Previous reduction works carried out so there is a lot of regrowth.

T2 - Pittosporum - Remove to ground level.

Large woody shrub/ tree, remove to provide clearance to path and front garden.

T3 - Holly - Reduce height by 50% and shape sides.

Maintenance works, previously reduced.

T4 - Lawson Cypress - Reduce height by 3-4m (to previous points), shape sides.

Maintenance works, previously reduced.

T5 - Leyland Cypress (Located withing neighbour's garden) - Remove to ground level.

Large fast growing tree creating heavy shading to rear gardens. Non native/ low habitat and amenity value.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
