- T7: Ash: Reduce height by 2.5 metre & Lateral spread by 2 metre.
- T8: Large Lime: Reduce height by 2 metre & Pollard back to previous points.
- T9: Large Scotts Pine: Reduce height by 2.5 metre & Lateral Spread by 2 metre.
- T10: Hawthorn: Reduce height by 1.5 metre.
- T11: Hornbeam: Reduce height by 1.5 metre & Lateral spread by 1 metre.
- T12: Hawthorn: Remove Ivy & deadwood throughout.
- T13: Ash: Reduce height by 2 metre @ Lateral spread by 1.5 metre.
- T14: Ash: Reduce height by 2 metre & Lateral Spread by 1.5 metre.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
