T1-Oak tree - (18m)-removal of dead branches, thin crown by twenty percent. Removal of epicormic shoots from main trunk up to crown break.

Reason for work-The tree is in poor health and the proposed work will improve the health and safety of the tree.

T2-Cypress trees in neighbours garden- prune back overhanging branches by up to 1m.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
