The application relates to a tree in the property behind us in Addington Close (we believe to be number 15) where a tree in their garden is near the boundary of our property. There are overhanging branches which, particularly when in leaf, are very near to the roofs of our buildings. We wish to cut back the branches but want to understand how much we are able to reduce these by and get permission for this before we proceed.

As an aside, the tree doesn't look too healthy and is being completely take over by ivy.

### Identification of Tree(s) and Description of Works

I have described previously the issue and location of the tree and cannot see where I can upload maps and photographs. We believe it is an ash tree.

Its difficult to see from the photos but the branches are all within probably 1 metre of our roofs

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
