Crown reduction to give the tree a balanced shape and reduce the windmill effect when strong winds occur.

Removal of the lowest bough.

After removal of the lowest bough the intended height from the ground to the first remaining bough would be approximately 30 metres and the width of the crown would be approximately 30 metres thus creating a balanced shape.

The tree trunk is approximately 5 metres from the house and the bough to be removed overhangs the single story part of the house. Removal would provide clearance to the property and avoid considerable damage if it fell.

The bough to be removed spreads over onto a neighbouring garden (St Edward's Lodge, High Street, Clifford.) The neighbours have voiced concern about the overhanging bough and its lopsided nature after recent extremely windy weather.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
