Identification of Tree(s) and Description of Works

We have a small-leaved lime tree that is very tall and blocking light from our house and garden. This has a negative impact on the property as well as residents and we wish to perform the following works:

Crown reduction to 8m height (from an estimated 10m)

Crown reduction to 6m width

Crown thinning by 30%

We believe that this will improve the light conditions of the property, as well as improving the look of the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
