Details of the pre-application advice received

Although the information submitted/available at this stage is quite limited, the proposed works do not immediately raise any principal concerns. On the basis that the rear lean-to is unlikely to be of any great historic interest, the proposed roof works seem unlikely to cause any harm. Further detail would be required before I could more fully assess the removal of fabric from the chimney stack, but potentially there is a blocked-up fireplace in the relevant location that would be beneficial to open up, if consisting of modern construction/fabric. This advice is informal officer opinion only and made without prejudice to the formal determination of any application. If you want a formal opinion then you will need to make an application with its associated supporting documentation, plans and fee. All applications will be subject to consultation and publicity and any proposal may be subject to a call-in by a Councillor for determination at Development Control Committee.
