ALL ITEMS INCLUDING REMOVING ARISING DEBRIS, LEAVING SITE CLEAN AND TIDY.  The intended works are for general upkeep and maintenance. The Chestnut is a fairly large specimen and just about encroaches 4 gardens. If left unattended, it would end up getting too large for the location. None of the works would be detrimental tree the tree nor affect the amenity value.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
