Sweet chestnut (T1) - 1 meter crown reduction. This is to crown reduce the sweet chestnut to previous cut marks completed in 2021 under TPO application ref: DC/18/2923/TPO. reasons for work are to reduce windthrow and garden clearance. Allowing an increase of light to the property. To maintain its managed size

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
