Reduction back to sound pruning points of Lime tree on the corner of Gold Hill and Cowl St, at the site of the Old Chapel. This will include a reduction of 3m in height around the crown of the tree. A tree surgeon has been consulted and quote and plan has been obtained. The tree has grown to the extent that it is intruding on the footpath and the road and could cause damage to cars and potential injury.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
