My preference is for the aluminium window, it allows the historic size of the opening to be read more clearly and is an honest modern intervention. We do need section details to properly understand how bulky it will appear though. A heavy frame would undermine the appearance of the opening. If it has a light frame this could look attractive. I'd also advise the frame be a dark colour/black to appear more discreet.
