T1 Sycamore; to sectional fell T1 Sycamore. T1 is showing significant signs of die back in the crown and an obvious ring around the base of the tree which is indicating that the root plate has movement, the tree has a natural growth lean toward the homeowner's property, the home owner is concerned that if the tree fails it will cause damage to his property.

T2 Beech; T2 has significant signs of decay at the base of the tree with a lot of bark peel revealing deadwood underneath, a large amount of bracket fungi was produced at the base of the tree (autumn 2023) which had been removed. The tree has a natural growth lean toward the homeowner's property and the neighbour's, the home owner is concerned that if the tree fails it will cause damage to his and the neighbour's property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
