Ridge height of link roof raised to create a first floor connection between the existing house and main extension.

A new staircase will be installed within the link. The client is eighty years old so it's impractical to go down stairs and back up again as the current approved scheme indicates.

The link will remain concealed from view behind the existing house, ensuring no impact on the surroundings and no change to public views.

The approved scheme received unanimous support. There were no objections at committee with a unanimous decision in favour.
