Reduce four lowest limbs of Ash Tree situated in neighbour's garden (29 Oaklands Avenue) trespassing onto our property ((27 Oaklands Avenue) to be reduced by 2 metres. Limbs also encroaching onto our Bramley Apple Tree which we ask permission to have reduced by 2 metres. I attach photographs showing both trees.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
